**SUPPLEMENTAL DECLARATION OF  
FRED VANNATTA IN SUPPORT OF  
MOTION FOR PRELIMINARY  
INJUNCTION**

I, FRED VANNATTA, declare as follows:

1. I make this Declaration for the purpose of supplementing that Declaration dated October 9, 2007, which was filed in support of Plaintiffs' Motion for Preliminary Injunction.

2. I am also registered to lobby on behalf of Roman V Ranch, LLC and Oregon Anglers and Oregon Anglers Research Society. Copies of my lobby registration forms are appended hereto marked Exhibits 1 and 2.

3. I am the Managing Member for Roman V Ranch, LLC. Roman V Ranch, LLC is a limited liability company which includes my family members and owns approximately 1500

1 acres of timberland characterized as "small woodlands" in Oregon.


2 4. The Legislative Assembly has, over the past years, considered a variety of  
3 legislative proposals which would affect small woodland owners and would affect me in a direct  
4 economic sense. At the last session alone, the Legislative Assembly considered the following  
5 legislation which could have impacted or did impact the economic interests of small woodland  
6 owners, including me: Senate Bills 316 (relating to energy) and 514 (relating to special  
7 assessments) and House Bills 2115 (relating to forest products harvest taxation), 3044 (relating  
8 to fire suppression), 3364 (relating to tax credits for reforestation) and 3499 (relating to water  
9 quality).

10 5. In upcoming sessions, the Legislative Assembly is expected to consider further  
11 proposals relating to taxation, forest practices and energy (including bio-fuels) which will impact  
12 small woodland owners. I therefore intend to lobby on behalf of Roman V Ranch, LLC and  
13 myself for the purpose of defending my financial stake in the small woodlands and my limited  
14 liability company.

15 6. Oregon Anglers and Oregon Anglers Research Society are nonprofit  
16 organizations.

17 7. Because I have a legislative interest in proposals before the Legislative Assembly,  
18 I will be prohibited from engaging in the type of good will building activities referenced in  
19 paragraph 2 of my Declaration of October 9, 2007 to further political speech on my own behalf  
20 or on behalf of my clients.

21 I declare under penalty of perjury that the foregoing is true and correct, and that this  
22 Supplemental Declaration was executed on this 22<sup>nd</sup> day of October, 2007, at Salem, Oregon.
